TRUSTECH hosted the Inaugural Sustainable and Interoperable Identity (SIDI) Hub Summit

**17 major open-standard organizations** active in digital identity have launched SIDI Hub to promote a common understanding of what cross-border interoperability means and define a shared approach and roadmap for success.

**120+ digital identity experts** from governments, representing **22 countries**, multilaterals, standard and non-profit organizations attended, including representatives from the Organization for Economic Co-operation and Development (OECD), UN agencies and the World Bank.

**Over 90%** of participants agreed that the work started at the SIDI Hub summit must continue in 2024.
